Though I may not embrace these principles I agree not to express opposition in any way to the detriment of the Mission program.

Muncie Mission Ministries was reviewed by the Indiana Department of Workforce Development in 1995 and a determination was made that the Mission does not qualify as an employer under code IC22-4-7-2(h). It was found that Muncie Mission Ministries is an organization that is operated primarily for religious purposes and is supported by the churches in and around Muncie.
